Thank you for your letter of September 22nd. I have just returned from Japan, hence the tardy answer to your questions.

I have now had a chance also to check the questions you have asked:

- a) whether and when Futuro Corporation of Philadelphia has filed a bankruptcy case yes, several months ago. Futuro Corporation filed for bankruptcy under Chapter 11.
- b) whether Mr. Fruchter has transferred the license-agreement I have asked our attorney, Mr. Edward C. Eppich, to answer that question, and you will be hearing from him directly by letter.

Cocke, I'm afraid that our legal contact in Philadelphia made an error in stating that your company was not listed as an unsecured creditor by Futuro Corporation. As you will see by the attached letter, you are indeed listed by Futuro Corporation as a creditor in the amount of \$12,325. For some reason, and to our great embarrassment, this notation was overlooked previously - and I am indeed sorry. For your information, I am also including the 19 pages listing unpaid amounts totaling slightly over one half million U.S. dollars.
